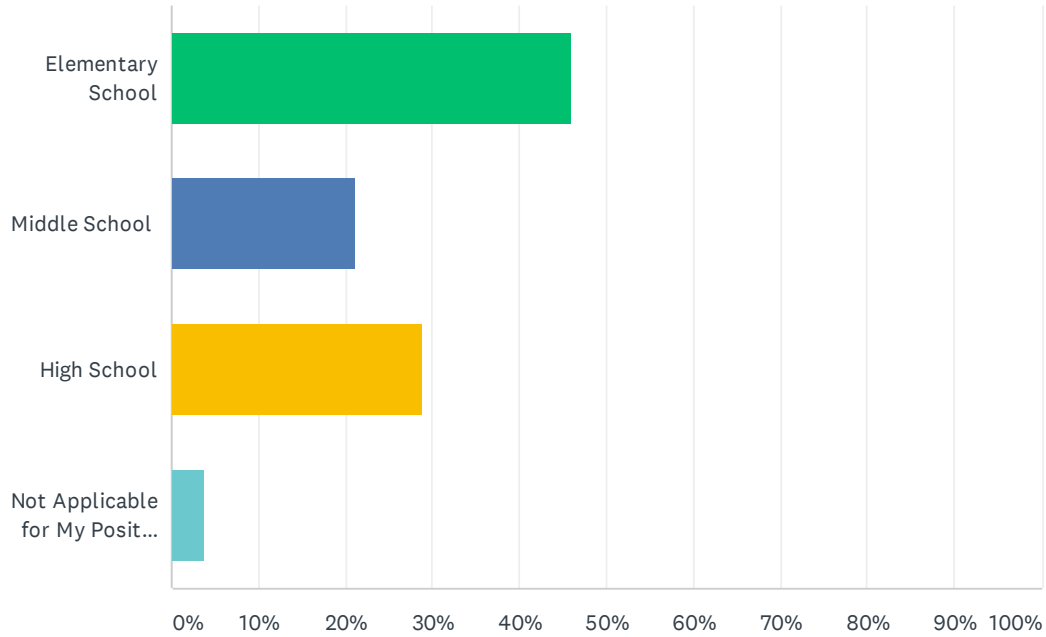


Q1 Are you based at a...

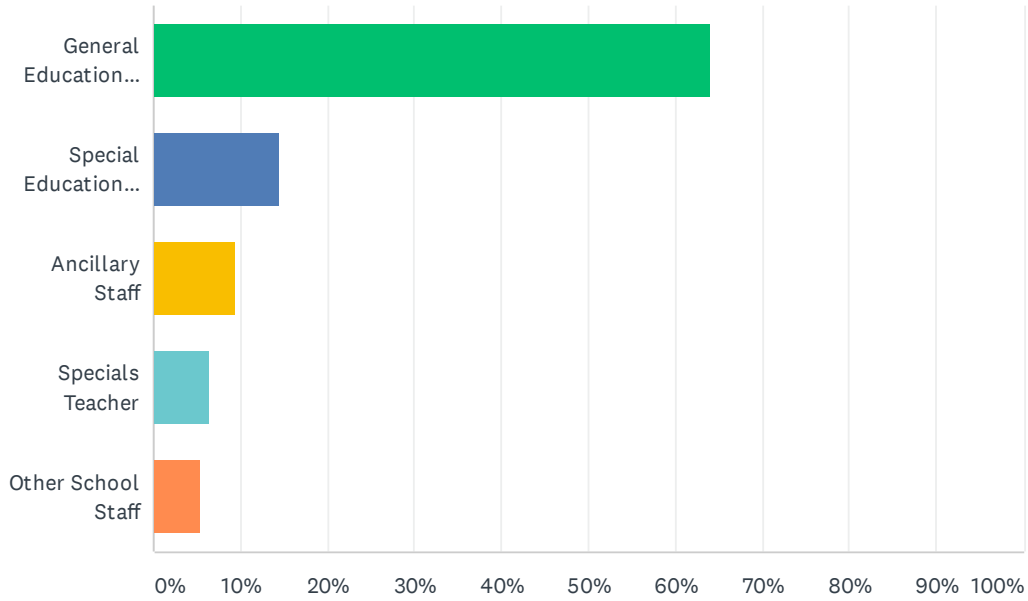

Q2 What best describes your position

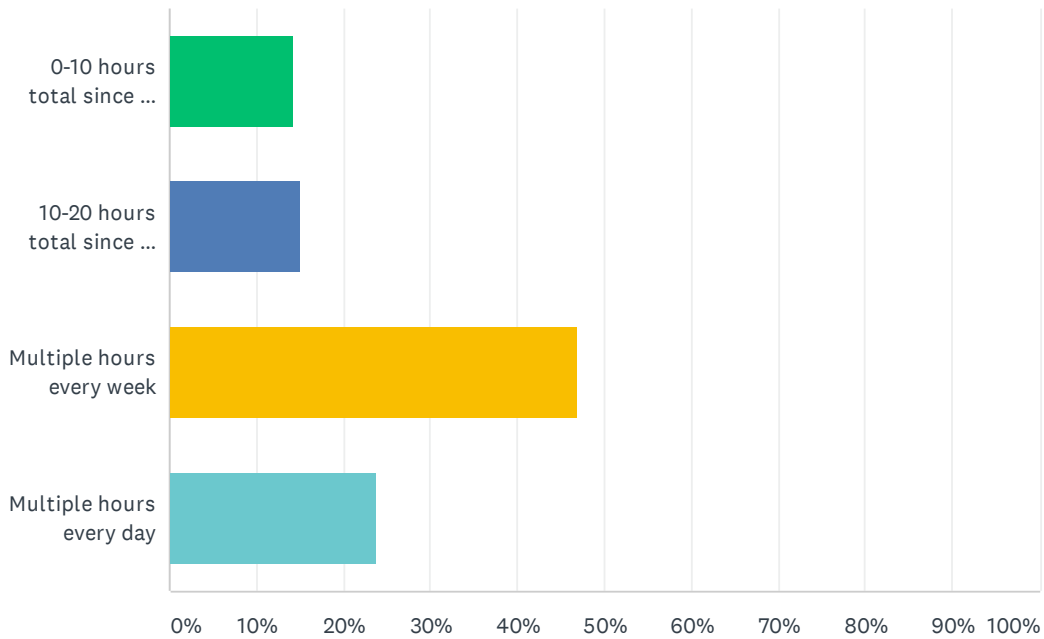

Q3 Due to the complications in district technology, how much time have you had to spend working outside of contract hours

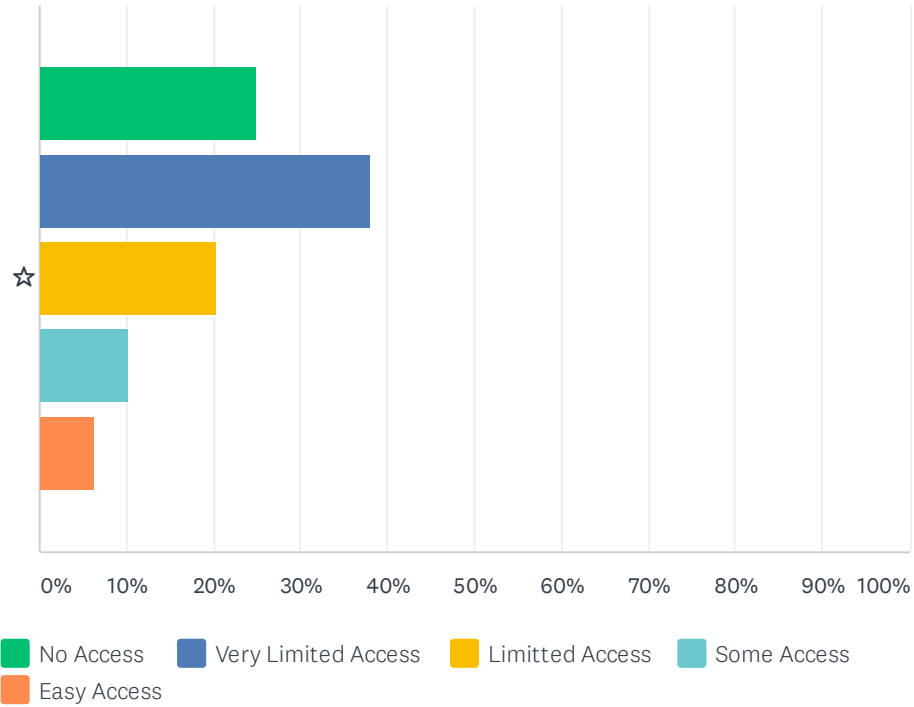

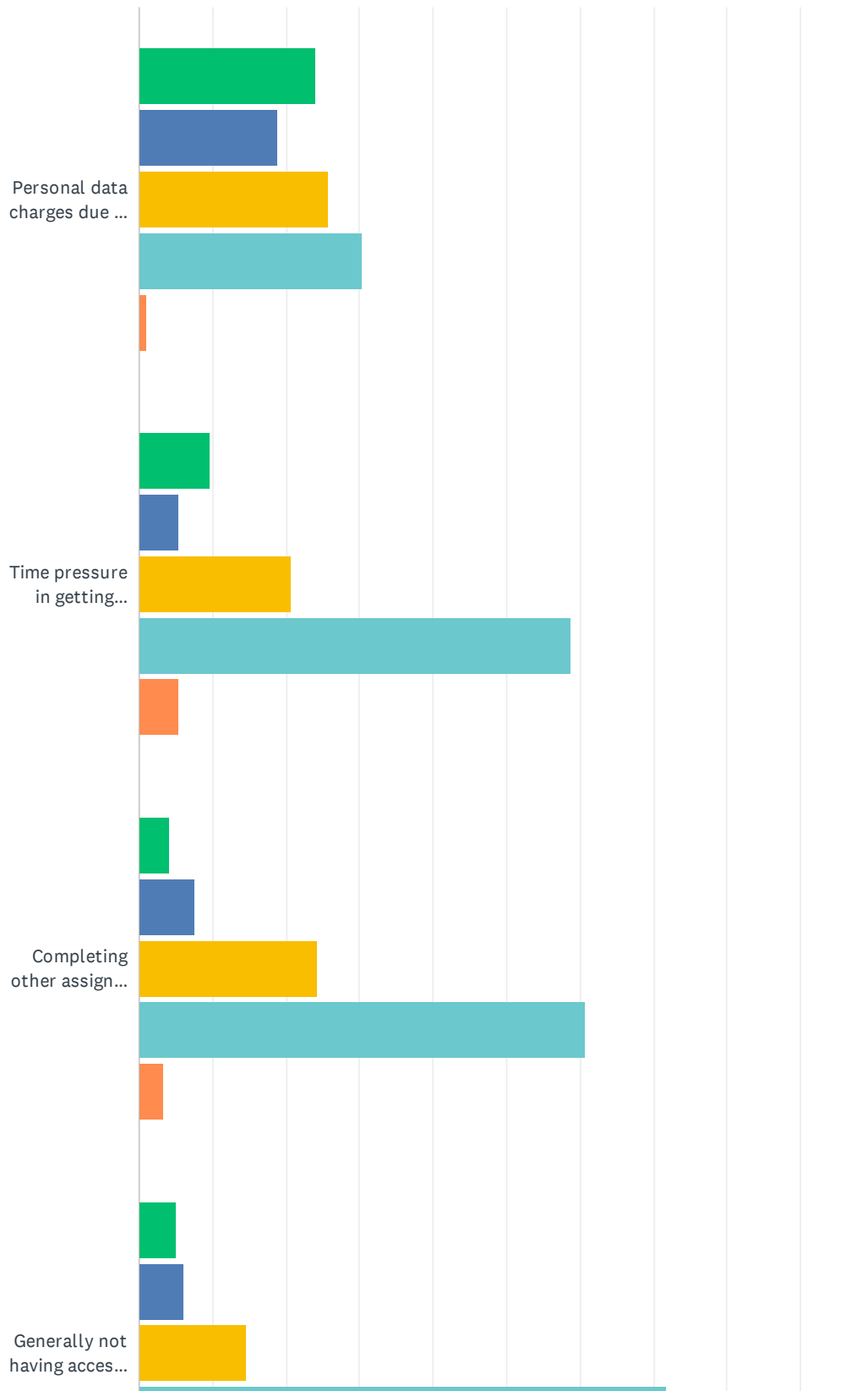

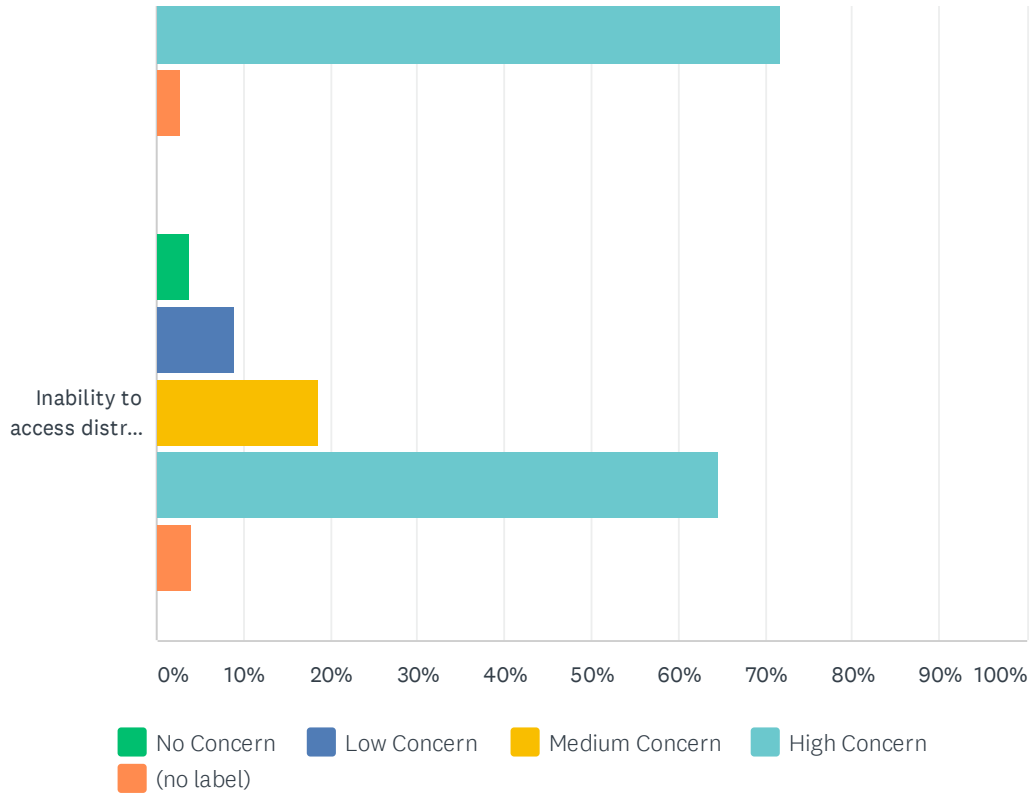

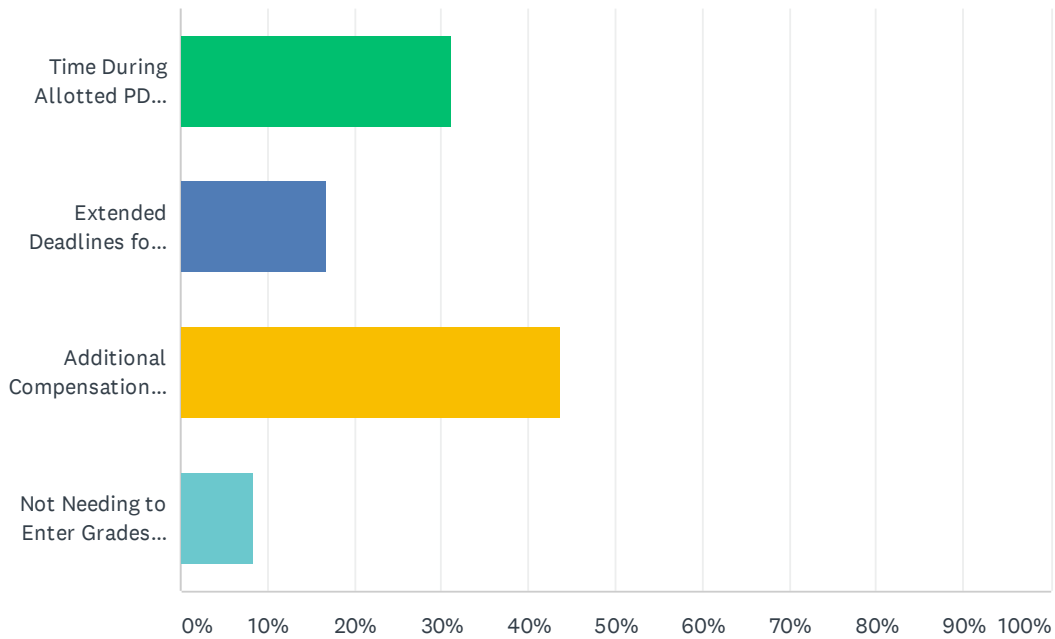

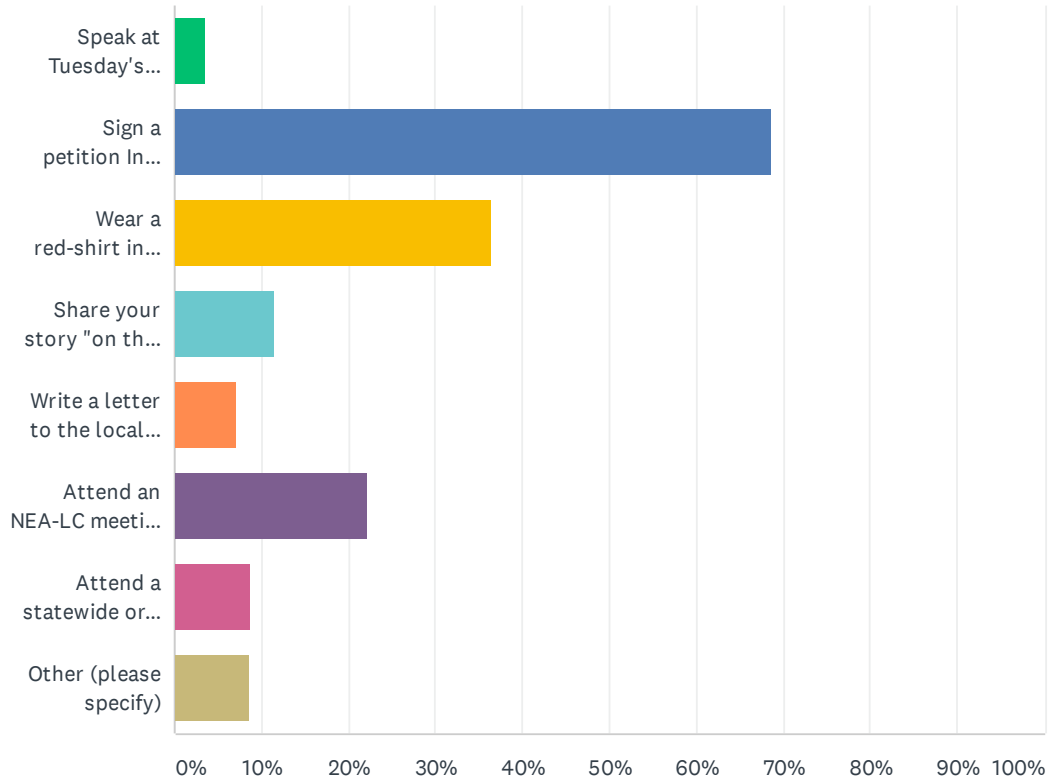
